Runners will be awarded up to 1,000 points for each race, plus 100 bonus points for each athlete who competes in all 5 races. Athletes who participate in any race will automatically be entered in the series. Points for each race are calculated as follows:

$$\frac{\text{Best Time in race, in your gender}}{\text{Your Finish Time}} \times 1,000 = \text{Number of Participants}$$

Cash prizes will be awarded to male and female Series finishers: **Overall** 1st, 2nd, 3rd (\$175, \$150, \$125); **Masters:** 1st, 2nd, 3rd (\$120, \$100, \$75). The Sayville Running Company will also award \$50 gift certificates for the winner of each 5 year age group from under 10 to 85+.
